

Privacy Policy Parkeagle B.V.

This is the Privacy Policy of PARKEAGLE B.V., a company having its address at Entrada 501, Amsterdam-Duivendrecht. Our Privacy Policy explains how we collect, use, share and protect information in relation to our ParkeerSlim App mobile services, our website www.Parkeagle.com, and any software provided on or in connection with «=naam_kort» services (collectively, the "Service"), and your choices about the collection and use of your information. By using the Service, you understand and agree to the collection and use of information in accordance with this Privacy Policy. Our Privacy Policy applies to all visitors, users, and others who access the Service ("Users").

What kind of information do we collect?

The information you provide

We collect the following information you provide us with directly:

- a. Your name;
- b. Your phone number;
- c. Your address;
- d. Your username, password and e-mail address when you register for a PE account;
- e. Profile information that you provide for your user profile;
- f. Communications between you and PE (e.g., we may send you Service-related emails);

Log file information

We collect information that your browser sends whenever you visit our Service. This log file information may include information such as your computer's Internet Protocol address, browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages and other statistics.

Location information

We may use and store information about your location if you give us permission to do so. We use this information to provide features of our Service, to improve and customize our Service. You can enable or disable location services when you use our Service at any time, through your mobile device settings.

How do we use this information?

We use all of the information we have to help us provide and support our Services. Here is how:

- a. remember information so you will not have to re-enter it during your visit or the next time you visit the Service;
- b. provide, improve, test, and monitor the effectiveness of our Service;
- c. To help you efficiently access your information after you sign in;
- d. monitor metrics such as the total number of visitors, traffic, and demographic patterns;
- e. diagnose or fix technology problems;
- f. develop and test new products and features, and;
- g. automatically update the PE application on your device

How is this information shared?

We will not rent or sell your information to third parties outside PE.

Change of control

If we sell or otherwise transfer part or the whole of PE or our assets to another organization (e.g., in the course of a transaction like a merger, acquisition, bankruptcy, dissolution, liquidation), your information collected through the Service may be among the items sold or transferred. The buyer or transferee will have to honor the commitments we have made in this Privacy Policy.

Legal requests and preventing harm

We may access, preserve and share your information in response to a legal request (like a search warrant, court order or subpoena) if we have a good faith belief that the law requires us to do so. We may also access, preserve and share information when we have a good faith belief it is necessary to: detect, prevent and address fraud and other illegal activity; to protect ourselves, you and others, including as part of investigations; and to prevent death or imminent bodily harm. Information we receive about you may be accessed, processed and retained for an extended period of time when it is the subject of a legal request or obligation, governmental investigation, or investigations concerning possible violations of our terms or policies, or otherwise to prevent harm.

Safety and security

PE has taken appropriate technical and organizational measures by using the latest technologies to protect your information against loss or unlawful processing. We use safeguards to help keep the information collected through the Service secure and take steps (such as requesting a unique password) to verify your identity before granting you access to your account. However, PE cannot ensure the security of any information you transmit to PE or guarantee that information on the Service may not be accessed, disclosed, altered, or destroyed. We request you to do your part to help us. You are responsible for maintaining the secrecy of your unique password and account information, and for controlling access to emails between you and PE, at all times. We are not responsible for the functionality, privacy, or security measures of any other organization.

Retention period

In accordance with the law, PE does not retain data any longer than is required for attaining the purposes for which they were collected.
